DESCRIPTION OF BUILDING PRODUCT

Brad nails (brads) are have a smaller head and finer gauge. They are intended to be used where less obvious fixings are required such as installing skirtings, decorative linings, or in joinery. While brads have less holding power than other fixings this is not a consideration as less holding power is required.

ECKO brads are supplied either electro-galvanised or 304 stainless steel.

- The DA series is 15 gauge and angled 34°.
- The FN series is 15 gauge and angled 24°.
- The AG16 series is 16 gauge and angled 20°.
- The C series is 16 gauge and straight.

All ECKO brads are supplied so that they may be installed with bradders.
